

ELDERS WEATHER SURVEY PROMOTION 2026 TERMS AND CONDITIONS

1. The promoter is Elders Rural Services Australia Limited (ABN 72 004 045 121) (**Elders**) of Level 10, 80 Grenfell Street, Adelaide SA 5000.
2. Elders' Weather Survey promotion (**Promotion**) commences at 7:30am ACDT on Thursday, 29 January 2026 and closes at 8:00pm ACDT on Thursday, 2 March 2026 (**Promotion Period**). Except as otherwise stated all times are ACST/ACDT (as applicable).
3. To be eligible to enter the Promotion, you must:
 - 3.1. be:
 - 3.1.1. an individual residing in Australia over the age of 18 (including those in a trustee or executor capacity);
 - 3.1.2. a registered user of the Elders Weather application ("**Elders Weather App**");
 - 3.2. during the Promotion Period, complete the Elders Weather App experience survey ("**Survey**") during the Promotion Period and indicate your desire to enter the Promotion by ticking the relevant box marked "**Enter Promotion.**". Entry is open to individuals meeting the criteria in clause 3.1 and located in South Australia, Victoria, Western Australia, Queensland, Tasmania, New South Wales, Northern Territory or Australian Capital Territory;
 - 3.3. accept and comply with these Terms and Conditions, (referred to as an "**Eligible Entrant**").
4. There is no cost or fee to enter the Promotion. You may only enter the Promotion once.
5. There are 20 prizes to be won, with a total prize pool value of \$2,000. The prizes are 20 x \$100 Activ Visa Digital eGift Card from BHN Corporate Card Store (collectively, the **Prizes** or individually, a **Prize**).
6. Prizes are not transferrable or redeemable for cash or store credit.
7. Promotion draw process for Eligible Entrants into the Promotion:
 - 7.1. Eligible Entrants are automatically entered into the Promotion;
 - 7.2. Draws will be made via random selection using an electronic number generator from all Eligible Entries and the draw conducted by a representative of Elders at Level 10, 80 Grenfell Street, Adelaide SA 5000 at 12:00pm on Tuesday, 3 March 2026;
 - 7.3. Each Eligible Entrant may win only one (1) Prize and in the event an entrant's name is drawn twice (if not removed) the representative of Elders will select another entry at random;
 - 7.4. Prize winners will be notified by email within 7 days of the draw; and
 - 7.5. If after making reasonable attempts to contact or locate a winner, Elders is unable to do so by Tuesday, 10 March 2026 then that fact will be published in an appropriate forum and a redraw will be conducted at 12:00pm on Tuesday, 17 March 2026, in the

same manner, at the same location and from the same pool of remaining Eligible Entries.

8. Details (last name, first initial and postcode) of each winner will be published on Elders' website, www.elders.com.au on Tuesday, 17 March 2026 or, in the event of a redraw, on Tuesday, 31 March 2026;
9. Elders will use reasonable endeavours to deliver the Prizes within 28 days of the draw or any redraw. Delivery will be at Elders' cost as will any administrative costs associated with delivery.
10. Each winner must participate and cooperate (as required by Elders acting reasonably) in publicity activities relating to the Promotion, including, without limitation, being interviewed, photographed, filmed and recorded. Each winner authorises Elders to use the content subject of this clause for advertising and publicity purposes in any platform in perpetuity worldwide.
11. Elders reserves the right to:
 - 11.1. confirm an entry into the Promotion is valid;
 - 11.2. seek or request further materials from you in relation to your entry/ies and compliance with these Terms and Conditions;
 - 11.3. disqualify you if you:
 - 11.3.1. tamper with or benefit from any tampering with the entry process or with the operation of the Promotion;
 - 11.3.2. act in a disruptive manner or act with the intent or effect of annoying, abusing, threatening or harassing Elders or their respective officers, directors, employees, agents or contractors (including those of a related body corporate); or
 - 11.3.3. contravene these Terms and Conditions.
12. Elders' decisions in relation to the Promotion, including the eligibility of transactions to participate in this Promotion and the drawing process are final.
13. Elders, or any of their officers, employees, agents, contractors or related bodies corporate are not responsible for:
 - 13.1. lost, illegible, misdirected, incomplete or damaged entries; and
 - 13.2. incorrect or inaccurate transcription of information (including contact information), human error, technical malfunctions, lost or delayed entries.
14. By participating in this Promotion, you acknowledge, consent and agree that Elders may:
 - 14.1. collect, use and store your personal information to conduct the Promotion including names and addresses;
 - 14.2. disclose your personal information to its related bodies corporate, contractors and/or agents to assist it in conducting the Promotion; and
 - 14.3. disclose your information to third parties to comply with trade promotion laws and regulations which may include publishing your name as detailed in these terms (see

clause 1) if you are a winner of a prize or providing your name to a regulatory body to comply with any record keeping or auditing requirements.

Subject to any law or regulation to the contrary, if circumstances beyond Elders' reasonable control arise where a Prize becomes unavailable, then Elders reserves the right to substitute that Prize for a similar alternative of the same value or greater value if (after making reasonable attempts) it fails to reach mutual agreement with the winner in relation to a substitute.
17. If for any reason this Promotion is not capable of running as planned, then Elders reserves the right in its sole discretion to cancel, terminate, modify or suspend the Promotion subject to any required approvals or consents from authorities or regulatory bodies.
18. You are responsible for any taxes, duties, charges or expenses that may be due and payable because of you:
 - 18.1. participating in the Promotion;
 - 18.2. accepting, receiving (other than with respect to delivery of the Prize), owning, insuring and using the Prize.
19. To the maximum extent permitted by law, you:
 - 19.1. release and forever discharge Elders including its officers, employees, agents, contractors, representatives and related bodies corporate from any and all claims, suits, causes of action, obligations, sums of money, accounts, costs and expenses that you have, or in the future may have, against them in law and in equity arising out of, or in any way relating to the Promotion or the Prize; and
 - 19.2. indemnify Elders including its officers, employees, agents, contractors and representatives against all claims, costs, liabilities, losses and expenses which they pay, suffer, incur or are liable for arising out of, or in any way relating to your participation in the Promotion and your failure to comply with these Terms and Conditions or use of the Prize.
20. Any Prize supplied by a third-party supplier is subject to any applicable terms and conditions of that third-party supplier. You warrant and agree that you will familiarise yourself with any applicable terms and conditions as necessary.
21. Employees of Elders and their immediate families, associated or related companies and agencies, and suppliers involved in the Promotion, are ineligible to enter the Promotion.
22. If an entrants' contact details change between the date which they enter/it enters the Promotion and the date the winning entries are drawn, the Eligible Entrant must notify Elders of their/its correct contact details in writing immediately. Any failure to do so is at the Eligible Entrants risk.
23. Any dispute arising out of or in relation to the Promotion shall be governed by the laws of South Australia and the parties submit to the exclusive jurisdiction of South Australia.
24. Elders' failure to enforce any of its rights under these Terms and Conditions does not constitute a waiver of those rights.

25. A reference in these Terms and Conditions to 'dollars' or '\$' is a reference to the lawful currency of Australia.
